

Meeting Minutes

The meeting was called to order by Lt. Governor Jan Larson. Buford Rowe, Secretary of the West Knoxville Club, host for the meeting, led the singing of “America,” Charles Wareing, President of the West Knoxville Club, led the Pledge of Allegiance to the flag, and Gail Keown of the Alcoa Club offered the invocation.

Acting Secretary Bob Ergenbright, Lt. Governor Elect, called roll: Alcoa (10), Farragut (1), Foothills (0), Jefferson County (0), Knoxville (2), Maryville (6), Morristown (2), Newport (4), Northside Knoxville (4), Norwood Knoxville (0), Sevierville (3), West Knoxville (11), and Westtown Knoxville (2).

Past Lt. Governor Don Jones presented a detailed treasurer’s report of the 2003-2004 fiscal year income and expenditures. Division 5 began in October, 2003, with a balance of \$488.79 and ended the year in September, 2004, with \$1,282.69 in the checking account. A copy of the full report accompanies the original of these minutes. Each person present at the meeting received a copy. The report was accepted and approved by those present.

Lt. Governor Jan Larson thanked the West Knoxville Club for hosting the pizza party for meeting participants.

In the absence of Secretary Audrey Jones, whose schedule took her to Texas at the time of this meeting, there was no secretary’s report.

Upon recommendation of Jan Larson, Bob Ergenbright was affirmed as the new Secretary/Treasurer of Division 5 for this fiscal year.

Lt. Governor Larson continued with the following announcements:

- Each club secretary needs to submit a copy of their rosters to the Lt. Governor,
- Also, send a copy of each add/drop form to her as well,
- Deadline for monthly reports is the 10th of each month. Secretaries may e-mail the report to her if they wish,
- Clubs were reminded that club projects are only those that are sanctioned by the club Board of Directors and not just any individual projects,
- Reports should be shared with all members in the club through e-mail, newsletter, announcements, or any other appropriate vehicle,
- Club treasurers should forward a copy of their service and administrative budgets to the Lt. Governor,
- As presidents share up-coming programs with Jan she will forward the information to all other clubs in the Division,
- Be sure to contact clubs as a courtesy before you interclub with them. Sometimes clubs move their meeting dates and/or places and times,
- Everyone should consult the K-T website for information about the District scholarships nominations for which are open to the children and grandchildren of any Kiwanian. Nominations are due by January 31, 2005,
- Information concerning the International Convention in Hawaii this summer is in the new Kiwanis magazine and on the Kiwanis web site.

Pat Marshall, President of the Alcoa Club, introduced the Dollywood International Festival Kiwanis Day. For more information, contact President Marshall at the Alcoa Club.

Charles Wareing announced that the West Knoxville Club had received a \$2000 grant for their projects that support children in the Knoxville area.

Michelle Hatmaker, President of Circle K on the Maryville College campus, and Allison Pierce from the UT impending Circle K reported on their respective activities.

Representatives of the Key Clubs at Bearden, Maryville, and Cosby High Schools reported that they were doing well and looking forward to an active year.

The Maryville Club has begun the process of chartering a new Builders Club at Heritage Middle School in Blount County.

Key Club Zone Coordinator Charles Harrington, Northside, announced the Key Club Convention in Gatlinburg's Park Vista Hotel, April 1-3, 2005.

Lt. Governor Larson passed out a sponsor responsibility sheet to help clubs strengthen their bonds with their sponsored youth.

Those who wish to begin a new Circle K or Key Club should consult the respective web sites for new rules and guidelines.

Two opportunities for service were announced:

- A Veterans Day Celebration at the Foundry with speaker Suzy Janes. The table reservation deadline is November 5.
- The Salvation Army would like Kiwanis Bell Ringers. Lt. Governor Larson handed out a detailed description of the project, which is open to all clubs in Division 5, complete with the stores where bell ringers are needed. If your club did not receive one of the handouts, contact Lt. Governor Jan to get one.

If a club meets on a given day at the same time that a sanctioned Kiwanis activity is scheduled, Kiwanians may attend and count the activity as a regular meeting attendance.

Upcoming Division events are:

1. the Division 5 Christmas Party on December 5 at Jan and Bill Larson's home. The Farragut and Westown Clubs will be hosts. Directions to the residence will be sent by e-mail to those who need them.
2. The official Kentucky-Tennessee District Governor's visit is scheduled on January 11 at the University Club in Knoxville. Tickets will cost \$25. The event is hosted by the Knoxville and Northside Clubs.

The remainder of meeting time focused on highlight reports from the following clubs:

Maryville (Lonas Overholt), Newport (Rachel Ward), Northside (Tom Mattingly), Morristown (Edgar Grey), Alcoa (Pat Marshall), Farragut (Dan Johnson), Westown (Jan Larson), and Sevierville (Marc Robertson).

The Council was adjourned at 7:12pm.
